GENERAL INTENT:	<ol style="list-style-type: none">1. To provide a framework for future development decisions in The Rural Municipality of Piney.2. To outline policies for the protection of urban, recreational and environmentally significant areas within the Municipality.3. To establish policies for livestock production in the Municipality and to establish an application process for livestock operations including siting requirements, public notification, technical reviews, etc.4. To categorize rural lands within the Municipality into the four land use designations as identified below and as illustrated on the map (available on the RM website http://www.rmofpiney.mb.ca/administration/ or for viewing in the Municipal office):<ul style="list-style-type: none">▪ <i>Limited Rural Area</i><ul style="list-style-type: none">- The establishment of new livestock production operations is limited to recreational enterprises such as riding stables to a maximum of 20 animal units- This area acts as a buffer to the Settlement Areas.- Provision for the expansion of existing operations to a maximum of 100 animal units.▪ <i>Rural Area 1</i><ul style="list-style-type: none">- Provision for the expansion of existing operations to a maximum of 800 animal units provided that they meet setbacks based on <i>The Provincial Land Use Policies</i>.- Provision for the establishment of new livestock production operations to a maximum of 800 animal units provided that they meet setbacks based on <i>The Provincial Land Use Policies</i> + 25%.▪ <i>Rural Area 2</i><ul style="list-style-type: none">- Provision for the expansion of existing livestock production operations to a maximum of 300 animal units provided that they meet setbacks based on <i>The Provincial Land Use Policies</i>.- Provision for the establishment of new livestock production operations to a maximum of 300 animal units provided that they meet setbacks based on <i>The Provincial Land Use Policies</i> + 25%.▪ <i>Rural Area 3</i><ul style="list-style-type: none">- Provision for the expansion of existing operations to a maximum of 200 animal units provided that they meet setbacks based on <i>Provincial Land Use Policies</i>.- New livestock operations are prohibited.
