GRASS FIRES

The RM of Piney would like to remind all rate payers within the municipality that burn permits must be acquired through Manitoba Conservation before burning. Time frames and rules of the permit must be followed at all times. It is your responsibility to maintain control over the fire.

We must stress the importance of acquired burn permits and following the rules laid out by Manitoba Conservation. If these rules and regulations are not followed, the RM will consider charging costs to any rate payer not following the requirements.

VASSAR AND SANDILANDS WASTE DISPOSAL SITES **OPEN IN MAY FOR YARD WASTES**

The Vassar and Sandilands Waste Disposal Sites will be opened to the public on each Saturday in May of this year from 10:00 a.m. till 6:00 p.m.

Only yard debris such as trees, flax straw, grass clippings, branches, leaves, and natural debris left from storms can be dumped at these waste disposal sites on the following days:

Saturday, May 3rd, 2014
Saturday, May 10th, 2014
Saturday, May 17th, 2014
Saturday, May 24th, 2014
Saturday, May 31st, 2014

The dumps will be open only for the month of May and will only be receiving yard waste. No household garbage, recycling, or any other non-burnable debris will not be accepted at these dump sites.

Woodridge, Menisino/Piney, and Sprague waste disposal sites will remain in operation as is now.
