RURAL MUNICIPALITY OF PINEY

BY-LAW NO. #106/2014

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF PINEY TO ESTABLISH SPECIFIC OPERATING RESERVE FUNDS FOR THE PURPOSE OF HOLDING FUNDS ALLOCATED FOR THOSE SPECIFIC SERVICES RELATED TO THE MUNICIPALITY.

WHEREAS Section 168 (1) of The Municipal Act L.M. 1996, c.58 provides as follows:

"A council may by By-Law establish reserve funds for any general or specific purpose."

AND WHEREAS it is deemed necessary and desirable to establish a reserve fund for the purpose of holding operating funds set aside for special or emergency operation expenses or maintenance and operation expenses.

NOW THEREFORE the Council of the Rural Municipality of Piney, enacts as follows:

- 1. THAT the following operating reserve funds be created:
 - a. General Government Services
 - b. Protective Services
 - c. Transportation & Drainage Services
 - d. Environmental Health Services
 - e. Recreation & Cultural Services
- THAT the Council of the Rural Municipality of Piney shall deposit to the Specific Reserve Funds, at years end, any funds deemed necessary by resolution of Council.
- THAT the purpose of the General Government Services Fund is for funding general services as deemed necessary by the Council of the Rural Municipality of Piney.
- 4. THAT the purpose of the Protective Services Fund is for funding protective and emergency services as deemed necessary by the Council of the Rural Municipality of Piney.
- THAT the purpose of the Transportation Operating Fund is for funding transportation & drainage services as deemed necessary by the Council of the Rural Municipality of Piney.
- THAT the purpose of the Environmental Health Services Fund is for funding solid waste or wastewater services as deemed necessary by the Council of the Rural Municipality of Piney.
- 7. THAT the purpose of the Recreation & Cultural Services Fund is for funding recreational or cultural services as deemed necessary by the Council of the Rural Municipality of Piney.
- 8. THAT all funds under By-Law #88/2012 "Being a By-Law of the Rural Municipality of Piney to establish a Transportation Operating Reserve Fund for the purpose of holding funds allocated for transportation services related to the municipality" be transferred to the Transportation & Drainage Services Fund;
- 9. THAT By-Law #88/2014 is hereby repealed;
