Road Weight Restrictions

- St. Labre Rd MM (Rd 27N and Rd 63E); PR 210 to Whitemouth Lake Rd (Rd 21)
- Vassar North MM from Vassar to the Junction of Whitemouth Lake Rd (Rd 20N)
- Vassar East MM (Rd 6N); Vassar East Rd to PR 308
- Municipal Road 12N from PTH 12 to PR 210;

Burning Permits

MB Conservation

April 1st, 2016 – November 15th, 2016 Authority of the Wildfires Act

As per Manitoba Conservation, burning permits are required from April 1st, until November 15th under authority of the Wildfires Act. Burning Permits can only be obtained from your local Manitoba Conservation Office. No burning is allowed before 6:00 PM or when winds exceed 15 km/hour unless authorized by a Natural Resource Officer.

Provincial Agreement

Main Market Road Set to end 2018

A long-standing, little known, provincial agreement is set to end and it could mean a massive tax hike for families and businesses in small towns across Manitoba.

As provincial election season gets underway — and candidates begin meeting us on the doorstep and at community events — we need to tell them the agreement must be extended.

For the last 20 years, the provincial government has funded Main Market Road maintenance in rural municipalities that were formally Local Government Districts, including the R.M. of Piney, R.M. of Reynolds, and R.M. of Stuartburn.

A "Main Market Road" designation refers to a section of road in our towns and villages that we use the most. Main Market Roads connect our local businesses to their customers at home and across the province. They connect our families to hospitals, schools, and community centres — and in emergencies they ensure first responders are there for us when we need them the most.

The Main Market Road maintenance agreement was struck in the late 1990s, when the government of the day was offloading the cost and responsibility for many provincial roads to municipalities. It was a trade-off that recognized our municipalities would be maintaining many kilometres of roads that only connect to provincial Crown Lands.

Often these Crown Lands provide the provincial government revenue — as they collect royalties for operations like logging and mining — but provide nothing to our municipal governments when we are stuck fixing the wear-and-tear the operations have on these roads.

The Main Market Road maintenance agreement is set to end in 2018. Without it, our communities could be hit hard as we struggle to find other ways to cover maintenance costs. It could mean municipal tax hikes as high as 40 per cent. That's a scary deal for our families, our neighbours and local businesses.

We need provincial politicians to commit to a fair deal.

The provincial government has a billion dollar annual budget for roads and bridges. Extending the agreement would cost less than three tenths of a per cent of that.

The next time you meet a candidate — please, ask them to take a stand and commit to continue funding Main Market Road maintenance for our municipalities.

We need your help as we keep pushing to make sure our communities are treated fairly.
