“Landfill Tipping Fee Policy”

Subject: Landfill Tipping Fees

A. PURPOSE:

This policy provides for compensation to be paid to the Rural Municipality of Piney by its Property Owners, Occupiers or Contractors working on behalf of its Property Owners or Occupiers for the dumping of waste at the Land Fill Sites.

The policy is being implemented to alleviate a portion of annual taxes being paid by the Rural Municipality of Piney taxpayers to support the Land Fill Site Operations.

B. POLICY:

The following terms are intended to provide the Municipality with basic guidelines to tipping fees within the Rural Municipality of Piney for the disposal of large volumes of solid waste.

All loaded vehicles are to be covered prior to arriving at the waste disposal site to prevent waste from falling off of the vehicle during transport. Failure to cover the load will result in a loss of dumping privileges at that point in time.

All material being dumped is at the direction of the landfill attendant. Failure to dump in accordance to the landfill attendee’s directions will result in permanent loss of dumping privileges and charges associated with remedying the inappropriate dumping. These charges shall be assessed against the property owner as to not become a burden upon the rate payers at large and may be collected as a tax against the property.

This policy may be amended from time to time by resolution.

C. TIPPING FEE RATE CHART

All tipping fees must be pre-paid at the RM of Piney Administration Office in Vassar, MB. No dumping will be permitted without the proof of payment.

Tipping fees are not applicable to clean burning, natural material or recyclables; excluding tree stumps. Clean burning material does not included painted surfaces, demolition rubbish, etc.

Fees for private garbage collection businesses working within the RM of Piney, collecting garbage from residential ratepayers will be determined by agreement. The RM of Piney may enter into a waste agreement without precedent.
