




Transit Plan – Report Summary SERIES #2 – Justification & Demographics

JUSTICATION: Current and past surveys identify the importance of transportation support as a quality of life issue and of sharing transportation to larger centers. Public consultation reveals four primary types of passengers (with other destinations and travel needs identified):

- 1. Seniors travel to medical appointments
- 2. Seniors community social activities
- Shopping in stores/services in Steinbach and Winnipeg
- 4. Events/attractions in the RM, Steinbach and Winnipeg

DEMOGRAPHICS: The RM of Piney is located in the southeast corner of Manitoba with a population of 1725 in a large physical area of 2433 square miles with 75% crown land. Many residents travel 1-2 hours northwest for shopping and services as there is no central community although Woodridge and Sprague are more populated. There has been growth particularly in Woodridge and Sandilands located closer to urban centers in the northwest section of the RM. Some also travelled south to the US prior to

Safe Services Plan and current Public Health Orders. As our The latest census identifies 35% of residents are 60+ years old. The median age is 51 and median income of \$23.962 as compared to \$34,188 for Manitoba.



Your Guide to Local Government

Administration & Staff

When a policy is created by council, who carries it out? Administration and staff are essential to the management of the RM. As a team, staff members work hard to provide things like newsletters, notices, building permits, road maintenance, and finance management for the RM (just to name a few).

Chief Administrative Officer: The CAO's responsibilities are widely varied. The CAO oversees administration, financial management, human resources, and provides Council with advice on legislative requirements.

Administrative Staff: The staff in the office are there to assist the CAO with financial and administrative duties. Answering public inquiries, preparing financial statements, organizing and filing, and updating the website are all part of their duties.

Public Works: The public works staff takes care of services rate payers use on a daily basis. They oversee and implement projects such as gravelling and paving, drainage, street lighting and civic address signage.

Other Staff Members: The RM can hire professionals or extra help for special projects and initiatives such as tourism, economic development and emergency management.

Sprague RCMP

Spring has sprung! Sprague RCMP is seeing increased traffic flow on our roadways as people return with the nicer weather to open their seasonal cabins. Unfortunately, this has also resulted in several reports of break ins that happened over the winter months, and went undetected until now. If you're the victim of a break in, or theft, call the Sprague RCMP to report the incident. We can't help if we don't know it's happened!

What can you do to reduce your risk? I'd suggest the following. If you can't come and check on your property through out the winter months, speak to your neighbours or friends who live in the area. Ask them to keep an eye out, and report suspicious activity or vehicles to the RCMP. Make sure you take anything of value with you when you close up for the season. This includes firearms! Never leave firearms in your seasonal residence over the winter months, even if you have a gun safe. The bad guys will just take the whole safe with them, and open it later. Don't leave items in clear view, and consider improving security/access to your property. A solid gate is going to stop more curious criminals than a rope gate, or nothing at all! If you would like more information on how to prevent thefts from your property, feel free to call the Sprague RCMP and speak to one of our officers. We'd be more than happy to speak with you about securing your property.

With the Province still under Code Red restrictions, Sprague RCMP Detachment continues to be closed for walk up service. If you are an essential worker, you can still get criminal record checks completed. Please contact our office at (204) 437-2041 to get further details. RM of Piney Fire Departments

April is here at last. Everyone is tired of being shut in and looking forward to getting outside. This is a month of natures transition from dormant winter mode to full bloom of summer. Until things green up, there is significant risk of wildfires that can get out of hand quickly putting nature, people, buildings and entire communities in danger. We all need to do our part to reduce and if possible, eliminate this risk.

April 1st is the date that Burn Permits are now required. This means that no open fires are allowed without a permit except in an approved fire pit. An approved fire pit can not have a fuel burning area bigger than 3 ft in diameter and 2 ft in height. Permits can be requested from Sustainable Development at 204-437-2348 or 204-346-6110. No burning is allowed before 6:00pm or when winds exceed 15 km/hr unless authorized by a Natural Resource Officer. Currently there is an Open Fires Burn Ban on for the RM that will remain in effect until further notice.

There are things you can do right in your own yard to help reduce your personal risk in the event of a major fire. By removing dry pine needles from your eavestrough or cedar mulch in gardens or window wells, you could reduce the risk of a house fire if a spark were to ignite near your home. Raking up dry leaves around your home and removing all wood piles that are piled against a building, are just a few simple ways to reduce the severity of a wildfire. With the warmer weather here, we can spend so much more time outside. Traditionally, to do yard work, home renovations, or perhaps use the BBQ. Often a spring yard cleanup could involve gasoline powered equipment such as: power rakes, mowers, trimmers, and wood chippers. I would like to remind you to please be careful with the fuels required for many of these tools. Things can get out of hand very quickly when it comes to handling combustible liquids. Ensure that fuel is stored in a proper sealed container designed specifically for the fuel being stored. The fuel container should also be stored away from direct sunlight or any heat sources.

Spring cleanup may also involve burn piles for yard waste. Please observe all fire regulations and be sure to get a burn permit. Let's ensure there will be no accidental fires in 2021.
