# **RM of Piney Transit Pilot**

Here's your opportunity to show support of transit in the RM of Piney. Book a door-to-door shopping trip for August 17th to Steinbach Clearspring Mall and/or mid September 2021 (date to be determined) to Winnipeg St Vital Center.

- 1. Trip to Steinbach Tuesday, August 17<sup>th</sup> will use the Vita Handi Transit (booking deadline August 13<sup>th</sup>) at a subsidized of cost \$30. Wheelchairs are accommodated.
- Trip to Winnipeg in September may use a bus charter (booking date to be confirmed in the next RM Newsletter) at a subsidized of cost \$40.



> Note this option may pickup up from community centers rather than your home.

### Current health directives must be followed including:

- Stay home if you are sick,
- All passengers and drivers must wear a non-medical mask during the ride
- Passengers are expected to handle their own bags
- More details will be sent to you after booking including Provincial Health guidelines on transportation https://www.gov.mb.ca/covid19/restoring/transportation.html

Depending on demand, priority may be given to those 60 years & better and those in need (unable to drive or don't drive) as seating capacity may be limited to 50%.

HOW TO BOOK - Call Mel Parent 204 437-2604 and provide:

- Your name, address, phone number, email (detailed info), emergency contact information
- Whether lift is required (wheelchair or unable to use stairs)
- Identify estimated time to shop to allow a schedule for passengers shopping preferences.

Trips may be cancelled due to lack of sufficient bookings or COVID19 health directives. These rides are separate and distinct from the current funding of essential trips for seniors and thus fares will be charged but are subsidized. Trips are expected to leave approximately 9am and return by 2pm for August 17th and return by 5pm for September, however are subject to passenger requests. If you are unable to go shopping after booking a ride, cancel ASAP, as others may be on a wait list.

# **Fall Hunting Lease**

By-Law No. 123/2017

As of August 15<sup>th</sup>, you can purchase a Fall Hunting Lease that will allow you to hunt on RM land from September 1<sup>st</sup> to November 30<sup>th</sup>, 2021. Leases are for hunting purposes only, recreational use will not be allowed. No permanent structures may be erected on municipal land; only temporary structures will be allowed and must be removed before the end of the lease. No trees are to be removed and no trails are to be made on RM land. Vehicles are only permitted on land during the retrieval of harvested game.

The cost of a Fall Hunting Lease is \$500.00 for one (1) permit that allows up to five (5) individuals permission to access one parcel of RM land during one regular season.

#### **Customer Service Tips**

One of the great things about doing business in small communities is that business owners and customers are often on a first-name basis - they are friends, family and neighbours. But that friendly small-town way of doing business shouldn't mean that basic customer service is ignored. Great customer service will help ensure local businesses thrive and the products and services we all need will be available in our region for years to come.

#### What Businesses Can Do

**Be Responsive** – When customers or potential customers contact you, get back to them quickly. Even if you're busy. Customers deserve the piece of mind of knowing you respect their time and value their business.

Be Prompt – Show up when you say you'll be there. If something comes up that you're going to be late, call your customer to let them know. Most people understand when issues arise and are more than happy to wait or reschedule. Leaving them hanging is not respectful of their time.

Manage Expectations – Let your customers know if you decide to discontinue a product line or service, especially if it's an essential or once-a-year service. Ideally, provide a recommendation of another business that can provide the product/service. If that's not possible, give as much lead time as possible so your customer has time to find another supplier.

**Maintain Confidentiality** – If you are invited into someone's home or property to deliver a product or service, respect your customers' privacy. There's no need to share what you see or hear with anyone else.

#### What Customers Can Do

Resolve Issues Privately - If you have a less-than-ideal experience, contact the business directly. Business owners appreciate hearing from you to resolve any issues, rather than to hear about it on social media or through the rumour mill. On the flip side, if you have a great experience, let them know, either via phone call/email or on their social media channels. **Respect COVID Restrictions** – If you are visiting a business, respect the rules set by the government health authority. Business owners don't make the rules but they're in the difficult position of having to enforce them for their own safety and the safety of their customers. In addition, businesses have had to make many accommodations during this pandemic including expenses for personal protective equipment, time required for cleaning protocols between customers, and reduced numbers of customers – all negatively impacting their bottom line. Please be kind. Always.

### SECSC

#### **Community Housing Research Phase 2**

A group of dedicated volunteers conducted a housing survey back in September 2019 to kick off a renewed effort to provide housing options for seniors in the region. The survey results showed significant interest in a local housing community with day-to-day assistance. These volunteers incorporated the South East Community Services Co-operative (SECSC) to continue their work towards establishing housing and related services from a slightly different angle - a grassroots cooperative structure.

The SECSC housing community, aiming for completion in 2024, will offer twenty 500-square-foot units providing meals, laundry service, light housekeeping and 24/7 supervision in an affordable, secure group setting. The facility will cater to residents who can no longer (or choose not to) live independently but are not ready to move to a personal care home.

Sound like something you'd be interested in? If so, we need your input. To fund the project, SECSC is seeking funding from Canada Mortgage and Housing Corporation. As part of the application, SECSC is conducting a second phase of research with prospective tenants to participate in a 15 to 20-minute phone interview with Frank Scap of Outlook Market Research. All responses will be held in strict confidence. From all participants, we will be drawing in October for prizes from local businesses.
