#### **RM of Piney Transit Pilot**

The trip to Steinbach on Wednesday, September 15<sup>th</sup> will use the Vita Handi Transit, which can accommodate mobility devices including wheelchairs. <u>Booking deadline is September 13th at a subsidized of cost \$30; \$20 from Woodridge/Sandilands area.</u>

**Current health directives must be followed including:**

- All passengers and drivers must wear a non-medical mask during the ride



- Passengers are expected to handle their own bags/items

- Whether lift is required (wheelchair/unable to use stairs)
- Identify estimated time to shop to allow a schedule for passengers shopping preferences.
  - > Trips may be cancelled due to lack of sufficient bookings or COVID19 health directives.
- Trip is expected to leave approximately 9am and return by 2pm subject to passenger requests.

If you are unable to go shopping after booking a ride, cancel ASAP, as others may be on a wait list.

The RM of Piney is currently drafting the non-motorized trail plan. We are in the community engagement phase of the process. This phase seeks to gather resident and stakeholder input and involvement to help identify trail locations, priorities and features. The plan that is created will reflect the input that is gathered and will guide how, where, and when non-motorized trails are constructed. A 2<sup>nd</sup> virtual open house was held Wednesday, August 4<sup>th</sup>. This virtual open house reviewed the information gathered to date, sought additional input into the trail locations and prioritized trail development for each community. A summary of the survey information as well as the consultation materials including maps of trail locations is available on the RM website or by contacting Allison Driedger @bluestemdevelopment@gmail.com.

Any comments and input on the materials to date is welcomed and appreciated. We are hopeful that we will be able to have in-person consultation in the fall provided restrictions permit. These sessions would allow us to gather and discuss trail location and priorities in person. We look forward to hearing your thoughts and ideas.

#### **Economic Development**

#### Small Business Exit Strategy - Part 1

All business owners should have an exit strategy, a plan for the owner to exit their business while the business continues to operate for the benefit of employees, customers, suppliers and the community.

First step? Valuation. Many entrepreneurs don't know the value of their business. All too often, when it's time to retire (either planned or not) they just close the doors. It's not ideal for the owner to walk away with little more than assets to sell. It's unfortunate for their customers and the community who lose a thriving business they counted on. The impact on employees is devastating.

So, how do you figure out the value of your business? At its most basic level, business value equals assets minus liabilities. Your business assets include anything with a cash value, such as real estate, equipment or inventory. Liabilities include business debts, like a mortgage or bank loan to purchase equipment.

Business value can be increased by a number of other factors: productive workforce; strong established supplier relationships; high percentage of repeat sales and customers; no current lawsuits or tax complications; documented systems and processes for efficient business operations; established branding; and, potential for business growth or expansion.

Keep in mind that the opposite of any of these factors could result in a lower value. For example, an outstanding dispute with an employee, supplier or Canada Revenue Agency, could result in a decreased valuation. Worse, it could send an interested buyer running in the other direction.

Start by taking an objective look at your business and figure out how to improve any factors that could bring down the valuation. So, for example, if you currently use a shoebox for your accounting system, consider hiring a bookkeeper to set up an accounting program for easy financial management. Or if you're using your company Facebook page as a personal sounding board, now is the time to create a separate account so your business can build a strong relationship with customers. Taking these steps now will deliver the most benefit possible when it's time to exit your business, increasing the value.

Next month, we're going to discuss options for exiting your business – whether it's a succession plan that sees you transitioning out slowly or a cold-turkey departure. Until then, if you'd like to discuss any aspect of your business, my door is open (within all current public health guidelines, of course).

#### **Assessment & Taxation**

Council tries to balance the cost of services with a fair tax rate.

The **mill rate** is the ratio that has to be paid for every \$1000 of taxable assessment. Mill rate is developed based on the services Council wants to provide & their cost. These expenses are spread across the total assessed value of the RM.

Assessment is the estimated market value of a property. MB Assessment Services provides the market value of each property in the municipality every two years. The RM can only tax a portion of the property's market value. Different land uses result in different portioning. The equation for how property taxes are determined is: Mill Rate x Assessed Value / 1000.

Education tax is deemed an uncontrollable tax by the RM because it is established by the Public Schools Finance board and school divisions respectively. The RM is responsible for collecting property taxes, charging penalties, and putting properties onto tax sale for back taxes.

#### **Citizen Engagement**

Citizen engagement is paramount to how Council makes its decisions. Your experiences and input help guide decision-making. Several ways a ratepayer can have input is by:

**Public Hearings:** Public hearings are formal events, initiated by council or by an application from a citizen, held to gain public input on a matter of significant impact to the municipality. Public hearings are a way for Council to gain valuable feedback from the public on a new proposal before making the final decision.

**Open Houses:** Open houses and events such as Coffee with Council are informal meet-and-greets designed to engage with the public and gain new insights for improving the municipality. Citizens have the right to be informed about the municipality's policies, by-laws, programs and services.

**Access to Information:** Policies, by-laws, meeting minutes, and information on services are made available to ratepayers via the RM of Piney website <a href="www.rmofpiney.mb.ca">www.rmofpiney.mb.ca</a>. The RM keeps the personal identification of rate payers confidential.

Citizen complaints: If you have a comment or concern you would like Council to be made aware of, there are several options. 1) Put your concerns in writing and send them to the RM office, 2) request to be a delegate and take your concerns to a Council meeting, or 3) attend a public hearing or open house to make your position known. Citizen comments and concerns are reviewed in an unbiased manner, with the greater good of the municipality in mind.

#### **RM of Piney Fire Departments**

September already! Fall is around the corner and the seasons are starting to change. Also changing are the activities associated with this time of year. The risks and challenges change accordingly.

School starts in September and so do the school buses. Busses will be on the road twice a day. Please be aware of school bus warning lights and children moving around the bus at stops.

Fall is the time for harvest. There are all kinds of harvest, from digging your potatoes to combining wheat and chopping corn. With the operation of equipment comes the risk of farm accidents. Special care needs to be taken when preparing food for storage from the garden. Should we mention cutting your winter supply of firewood? Isn't there an old saying that firewood warms you tpwice? Once when you cut it and once when you burn it. Always wear safety equipment while operating chainsaw equipment in the woods and in the yard. Safety is always important.

Hunting seasons are opening up. There is always a chance of becoming disoriented in the bush especially with cloudy days and weather changes. Unfamiliar with the surroundings, the location of buildings and others is a recipe for disaster. Be aware of your surrounds, it is your responsibility as a hunter when discharging a firearm to keep everyone safe.

Is anyone still in the practice of piling straw bales around your house or mobile home to keep the floors warmer in winter? I'm sure I've seen firewood stacked against the house and on a porch for easy access too. Let's not increase the fire risk or add fuel to it. It's tempting to start that first fire of the year in the old wood stove and take the chill and dampness out of the house. When was the last time you cleaned your chimney? It's a lot easier now when there's no snow on the roof.

It is important to understand the risks which accompany our everyday activities. Injuries are preventable and planning ahead with safety in mind keeps everyone safe.
